Originally formulated for the laundry industry, use of Formula 747 has rapidly expanded to the food services, transportation, industrial machinery, hotels and motels, and building maintenance industries as well as to sewage treatment and garbage disposal and processing plants. Formula 747 is also environmentally friendly.

Directions For Use

Laundry pre-spotter: Spot stained area liberally; 'feather' with spotting brush if available. Allow ten to thirty minutes before washing. **Laundry additive:** Add in equal parts with wash detergent. **Drains:** Pour about 8 oz. '747' into drain and allow stand for up to one hour; then flush with hot water. **Grease traps:** Add about four ounces weekly, allow to stand for one hour, if possible, then flush. **Odor control:** Make 4 oz. per gallon dilution, then spray dumpsters, trash cans, other refuse receptacles and raw sewage areas. **Graffiti or heavily greased surfaces:** Prepare a thickened emulsion by mixing about 3 parts '747' with one part cold water, mix well and apply to surface by brush or sprayer. Allow to stay for 5-10 minutes; remove with a strong stream of water. **Gum and adhesives removal:** Apply product directly or via a thickened emulsion (see instructions above for graffiti removal) to surface where undesirable gum/adhesive is found. Allow product to work on stain for 5-10 minutes, use abrasive action as is needed to further loosen bond to surface, pick up liquid and rinse out completely with water. **Greasy machinery, equipment and parts:** Brush, wipe or spray undiluted product onto soiled areas, agitate when necessary and rinse with strong stream of water or high pressure steam.
